

## Pet Agreement

Resident(s) must obtain written permission from Management to keep a house pet in this park and must execute this Pet Agreement and Rules. Resident(s) understand(s) and agrees that the following are the only pet(s) allowed in the park pursuant to the Park's Rules and Regulations and that no pet of any guest of a Resident is allowed in the park.

Resident(s) agrees to comply with any state or local governmental law, regulation, or ordinance governing the proper inoculation and licensing of any pet allowed to remain in the park.

Resident also agrees to the following:

- 1. If a dog is allowed in the park:
  - a. Disturbances such as barking, snarling, growling, etc. which will annoy your neighbors is cause for revoking permission to keep your pet.
  - b. Any dog, when not inside the Mobile Home or RV must be on a leash and accompanied at all times. Dogs cannot be outside of the unit, without an adult being with them unless in an approved kennel.
- 2. Regardless of the type of pet:
  - a. No pet is to invade the privacy of anyone's unit, flowerbeds, shrubs, yard, etc.
  - b. No pets are permitted in the office, laundry room or any other company room or building, etc.
  - c. Droppings must be picked up and disposed of daily.
  - d. If a Resident loses a pet, written permission must be acquired from Management before replacing the pet in the event the park revises its Rules and Regulations to prohibit pets in the park, the Resident(s) shall not have the right to replace the pet.
  - e. No dog or other domestic animal is allowed to run at large in the park.
  - f. Animals running loose may be trapped according to applicable law & ordinances.
  - g. Cats <u>must</u> be spayed or neutered and not allowed to spray.

The park encourages pets to be spayed or neutered. However, in the event of offspring, the management must be notified and written permission must be obtained for the offspring to stay in the park for an interim period.

Further, Resident(s) understands that he and/or she is responsible for any damage to park property or the property of other residents caused by the pet, including waste and any disturbances or annoyances caused within the park.
